
## Why Reporting?

# 1.GRI Sustainability Self-Reporting Guidance

VNV Advisory's assists businesses in the development of GRI Sustainability Reports through trainings and capacity building programs. The Global Reporting Initiative (GRI) is a non-profit organization that has pioneered and developed a comprehensive Sustainability Reporting Framework that enables organizations to measure and report their economic, environmental, social and governance performance – the four key areas of sustainability . VNV Advisory's approach comprises of four phases.

### Our Approach



#### Phase 1

# Training on Addressing Sustainability Disclosures- Understand

VNV Advisory will provide an introductory training program on addressing sustainability disclosures. VNV Advisory's training program on addressing disclosures include

#### 1. Materiality- Connect

VNV Advisory will conduct materiality workshops to determine key sustainability priorities based on importance to stakeholders & impact on business, using the principles of GRI. Materiality helps organizations in determining the relevance and significance of key EESG aspects considering organization & stakeholder criteria. Material issues are those that influence stakeholder & organization decisions, actions and performance. Identifying such issues can help organization determine focus points & generate improvement strategies. VNV Advisory's materiality services guide organizations in strategic decision making & stakeholder engagement using globally recognized frameworks.

- Abiding by GRI reporting principles to define sustainability report content through materiality exercises. .
- Identification of key material aspects through materiality workshops, consulting internal and external stakeholders, as required to define important aspects to the organization.



# 2. GRI Sustainability Report Development

### Our Approach



#### 1.Scoping

VNV Advisory will engage with the top management to conclude on the scope and boundary of the report.

### 2.Stakeholder Engagement

VNV Advisory will engage with all influential stakeholders; which include both internal and external stakeholders as well as significant stakeholders within upstream and downstream supply chain.

#### 3. Materiality

Post stakeholder engagement, VNV Advisory will engage with the management in identifying sustainability aspects that are material, and of most importance to the company, taking into consideration inputs from all relevant stakeholders.

#### 4. Gap Analysis

Gap assessment will be conducted to understand necessary requirements to align with GRI standards

#### 5. Data Analysis

Data mining for the selected environmental, social, economic and governance indicators against a GRI checklist will be conducted and data request sheets will be distributed to relevant departments. Additionally personal interviews may be required with contact points in respective departments along with visits to operational sites

#### Report Generation

A draft report would then be prepared for verification and sent to the company's management for review. After verification & approval, a final report would be prepared & submitted

#### Report Design

VNV Advisory will design report based on organizational brand requirements.



#### 1.Scoping

VNV Advisory will engage with the top management to conclude on the scope and boundary of the report

### 2.Training

# 3.Data Inventory Collection

#### 4. Gap Analysis

Internationally Accepted Standards- GHG Protocol, IPCC, Water Footprint Assessment Standards will be used to analyse environmental footprint. A hotspot analysis will be included as a part of the data analysis to identify areas of maximal environmental impact.

#### 5. Report Generation

Based on the results of the data analysis, an environmental footprint report will be prepared, highlighting organizational environmental impacts at various levels-material, energy, water, waste, emissions & biodiversity. Environmental practises will be benchmarked against industry best practises. If required, VNV Advisory will help in the formulation of environmental best practises/policies to address the impacts.

#### 2.Training

VNV Advisory will conduct an indepth training with relevant stakeholders on various aspects of environmental footprint, including information on environmental benchmarking in the organization sector.

# 3.Data Inventory Collection

VNV Advisory would design a GHG Inventory based on international best practiced GHG Protocol Footprint Assessment. Data collection will be conducted through data request sheets and coordination with respective points of contacts. VNV Advisory may at this point, require on-site visitations to gather better understanding on processes and direction operations.

#### 4. Data Analysis

Internationally Accepted Standards- GHG Protocol & IPCC Standards will be used to analyse carbon footprint across all scopes-1,2 &3. This exercise is the process of establishing baselines, on which reduction strategies will be formulated. . A hotspot analysis will be included as a part of the data analysis to identify areas of maximal carbon impact.

#### 5. Strategy Appraisal

VNV Advisory will formulate a list of various strategies that may be adopted, along with suggestions on implementation mechanisms. The reduction strategies would account for absolute emission/consumption reduction on-site as well as focus on scope 3 emission reductions.

### 6. Report Generation

Based on the results of the data analysis & strategy appraisal, a carbon footprint report will be prepared, highlighting organizational carbon impacts at various levels. Energy management practises will be benchmarked against industry best practises. If required, VNV Advisory will help in the formulation of environmental best practises/policies to address the impacts.




# EIGHT.

## Social Impact Assessment

VNV Advisory will assist businesses by conducting "Social Impact Assessment" of their CSR projects, in accordance with the social framework. Our approach to SIA includes conducting CSR audits, identifying key stakeholders and conducting stakeholder engagement, data collection and analysis and, creating a detailed impact map of the interventions made. If required, social value of the projects will also be calculated based on the SROI framework. SIA is reported back to the organization through a "social impact report" explaining the outcomes, evidences and impacts created by the project.




#### Our Approach





# 1.ESTABLISHING SCOPE AND DATA COLLECTION.

VNV Advisory will understand the scope and develop a data collection methodology to extract required information for the study. Existent data points will be reviewed to understand the program and potential impact it would create.



# 2.STAKEHOLDER ENGAGEMENT AND MATERIALITY

VNV Advisory will identify relevant stakeholders who play key roles in the interventions and have significant impact upon them. At this point, VNV Advisory will require site visits to conduct stakeholder engagement through surveys, focus group discussions and interviews. Stakeholder and materiality matrix will be created to identify stakeholder involvement and key social issues resolved through the projects.



#### 3.IMPACT MAPPING

VNV Advisory will create a detailed impact map listing short-term, medium-term and long-term impacts of the programs. The impact map will include both intended and unintended outcomes



### 4.EVIDENCING OUTCOMES AND ASSIGNING FINANCIAL VALUES

VNV Advisory will help establish evidences for the identified material outcomes. For each material outcome, indicators of change will be developed to quantify them. Besides, duration of change will be identified to further strengthen the analysis. VNV Advisory will design customized datasheets to garner such information. After establishing these factors, local financial values will be applied to monetize those outcomes. This will allow computation of a ratio of benefits to costs as the measure of impact.



#### 5.ESTABLISHING IMPACT

During this stage, other aspects of calculations will be involved. VNV Advisory will create a tool to calculate different parameters such as Net Present Value of the project, SROI ratio, Payback period etc. Any aspects of change that would have happened anyway without intervention would be eliminated at this point.



#### 6.CALCULATION OF SROI

SROI Ratio will be calculated by summing all the benefits, subtracting any negative outcomes and comparing the result with the investment. At this stage, VNV Advisory will also conduct sensitivity analysis. The aim of such an analysis is to identify the strength of the model created for calculation.



#### 7. REPORT GENERATION

VNV Advisory will present a report explaining the social impact created by the education and skill development programs. The report will outline materiality matrix, outcomes and evidences, detailed impact map and social return calculation.




### Life Cycle Assessment

VNV Advisory's Life Cycle Assessment Services analyse the environmental aspects and potential impacts along the life cycle of a product using ISO 14040 and ISO 14044 Standards. LCA helps organizations in understanding the product/ process life cycle impacts by accounting for parameters like materials, emissions, water and wastes. Inputs and outputs are looked at each stage of the life cycle, in a cradle to grave, cradle to gate, or gate to gate approach. VNV Advisory will be using internationally recognized standards, and following globally accepted methodologies to conduct the LCA.

#### Our Approach









#### 1. Mapping & Scoping

Detailing our product/process specifics and defining system boundaries

- Boundary 1: All processes which are under direct control of the organization.
- Boundary 2: Processes that are controlled or influenced by organization.
- Boundary 3: Operations that are out of direct control or influence f organization.

Upstream assessment of supply chain by targeting top suppliers for primary data collection (For the rest, information will be derived from secondary databases). Downstream assessment of supply chain to understand use phase, and end of life phase.

#### 2.Inventory Analysis

Life Cycle Inventory across the life cycle stages will be conducted, focusing on parameters such as material use, water use, energy use, waste generation, emission generation. Inputs and outputs at various life cycle stages will be identified based on system boundaries. Inventory for transport, between different phases will also be considered.





#### 3.Impact Assessment

Assessment of impact of input and output parameters in life cycle based on ISO 14040, ISO 14044, ISO 14067, Product Life Cycle Accounting and Reporting, Water Foot printing Tool and GHG protocol using an internationally recognized LCA Database, supply chain assessment tool and VNV's in-house excel based tool for data collection and analysis. Impact identification will cover key issues like: Magnitude of environmental damage caused under different parameters (climate change potential, ozone depletion potential, energy usage, ocean acidification potential, eutrophication potential, biodiversity impact, impact on soil and water parameters etc.)

#### 4.Interpretation

An LCA report will be generated based on the results from the Inventory and Impact Assessments, VNV Advisory will prioritise impacts, based on the organization's internal performance agenda and upstream and downstream assessments. Evaluation techniques such as SWOT Analysis, Sensitivity Assessment, Scenario Analysis will be used for the purpose of strategy formulation.





## Supplier Sustainability Assessment

VNV Advisory's Supplier Sustainability Assessment Services include evaluating and approving exisiting suppliers against industry standards by quantitative and qualitative assessment. Implementation of sustainability practices across the organization's upstream and downstream supplychain to mitigate risks and drive continuous improvement.



#### Our Approach



#### 1. Supply chain mapping:

VNV Advisory will engage with Tier 1 and Tier 2 suppliers to document the exact source of every material, every process and shipments involved in the supply chain. This mapping exercise essentially makes a process visible which is then reviewed and analysed for improvement.

#### 2.Impact Quantification

VNV Advisory will gauge the impact of organization's operations against selective sustainability indicators. Impact quantification will be conducted primarily on energy, water and waste. This exercise will also involve boundary setting and scoping in lines with industry best practices and internationally recognized guidelines.

#### 4. Greening of Supply Chain

This process involves three different steps such as Evaluation, Supplier Code of Conduct and Supply chain strategy formulation.

- **Evaluation**: VNV Advisory will help in the formulation of scorecards for evaluation of suppliers. Suppliers will be evaluated based on a list of environmental and social indicators.
- Supplier Code of Conduct: VNV will develop robust guidelines for suppliers to create awareness on key components such as Ethics, Environmental policies and labour and Human Rights.
- **Supply Chain Strategy formulation**: Based on evaluation results, key sustainable supply chain strategies will be developed and implemented.

#### 4.Training

Training and improvement workshops will be provided to suppliers to improve supplier performance. Example, supporting them in developing effective EMS etc.

#### 5. Performance Monitoring

VNV Advisory will set supplier targets and performance indicators to gauge continuous improvement of your suppliers and contractors.
